She stated that the water tank project will be reimbursed by a grant from the Tobacco Commission and that a combined total of \$513,100 should be returned to the IDA by the end of this year or early next year.

#### **New Business**

HIT Park Consulting and Marketing Update

Mr. Weiss gave a summary report of the Data Center Dynamics - Connect Virginia Conference that he attended with Ms. White and Mr. Stanley in Loudoun, Virginia on November 11, 2023. He stated that Mr. Stanley and Ms. White took turns with him at the booth talking to prospects

about the HIT Park. He said that this event put Prince Edward on a global stage as there were attendees from around the world. He furthered that there had been some post-conference communication as a result of the event. Mr. Weiss stated that it is too soon to fully know the ROI of the event. He furthered that the amount of money spent on participating in this event was the right call and that he, Ms. White, and Mr. Stanley were able to focus on who was interested in the HIT Park without getting lost in the crowd. Mr. Weiss stated that there was only one other organization doing close to what the IDA is doing with the HIT Park which was a company with a high-rise building in St. Louis promoting the site as a potential data center location. Mr. Stanley added that the county was the only locality there; which exposed the county to more people. He said the availability of power and the cost of the site were very appealing. Mr. Weiss said that the other big plus is that the site is already zoned for a data center. Mr. Weiss stated that there was a site visit from a prospect before the conference and that the company was at the conference. The company presented a Letter of Intent to enter into a purchase agreement on the HIT Park. He stated that a response to the Letter of Intent is required today.

VDOT Commonwealth Transportation Board Business Park Access Road Grant
Mr. Stanley stated that the county is working with VDOT to get the business park access road into the system. He mentioned there is a clock ticking on using the grant and recouping the money. He furthered that the county has until January 2025, to get investments of \$3,250,000 and if not met, the county must repay the \$650,000 grant at a 20% rate. He mentioned that VEDP will be coming to the site soon which should encourage the state to send prospects to the county. He mentioned that the second lot is ready to start marketing.

#### **Closed Session**
