The Electoral Board Members were called to order by David Stockment, Chairman at 10:15 am. The Minutes of the previous meeting was reviewed and a motion was made by David Stockment and Seconded by Helen Pearson. Minutes stand approved as read.

The next order of business was to review all votes called to the General Registrar on the night of the election. After reviewing each precinct, all locations were accounted for and there were no discrepancies between what was placed on the website. We are very proud of our Poll Workers. We were able to train workers on electronic pollbooks. Poll workers were excited, and they were all grateful for this new way of voting called technology. The 45-day Early Voting which consisted of **173** voters who took advantage of the early voting. This election was a low turnout, as it was a Democratic only Primary.

The State Website currently shows unofficial numbers as received. After reviewing the numbers from precincts we moved on to the CAP for Early Voting in Person, Early Voting by Mail, and Absentee Ballots. All information reported from this precinct was correct.

We, the Electoral Board, by motion made by David Stockment and seconded by Helen Person, adjourned on Wednesday, June 18<sup>th</sup> at 12:30 pm, and will reconvene on Friday, June 20, 2025, at Noon as we finalize the processing of the June 2025 Democratic Primary Election results from Post-Election by Mail ballots and SDR ballots.
